



Junior Cricket Task Split

As part of the CJCC Governance Review Project, an initial assessment of current tasks taken on by local junior cricket associations has been made, along with a suggested split of these tasks in line with the recommendations of the project.

This task list is by no means exhaustive, and tasks differ significantly in size, but a good indication is given as to the proposed operations of the new governing body and the WA Cricket competition administration unit under the recommended amalgamation of junior cricket associations.

As can be seen in the below lists, tasks can be efficiently reallocated, benefiting from a reduction of duplication and a streamlined approach to competition management.

Current Associations Tasks	
Grade Splitting Decisions (Regrading or North/South Split)	Sponsorships and partnerships (e.g. balls)
Compliance Decisions	Portfolio development - Umpiring, Coaching, Female
Final Approval for Basic Dispensations	Legal reporting and compliance - AGMs, Finances, consitutions
Competition Protest and Dispute Oversight	Financial Management - invoicing, bank accounts, reconcillation
Hosting Protest and Dispute Hearings	General advice, consultation, feedback etc
Awards Night Organisation (in most associations)	Out of hours contact and advice
Umpire Availability/Appointments (in half of associations)	Local rules and nuances within global rules
Finals Match Managers (in some associations)	Trophy/Pennant Organisation
Book grounds for matches (just in PJCA)	Trophy/Pennant Presentation
