### **About the Role**

Metropolitan Junior Cricket Council (MJCC) is seeking expressions of interest from community-minded individuals to serve as **Tribunal Panel Members** for the 2025–26 junior cricket season.

This is a vital volunteer role that supports the MJCC's commitment to **fairness, integrity and inclusion** across Perth's junior cricket competitions. Tribunal Members play an important part in ensuring consistent and transparent outcomes when conduct or compliance matters arise under the MJCC Playing Conditions, Codes of Behaviour, and MJCC/Cricket Australia policies.

Tribunal Members sit on independent panels to hear and determine matters involving **players**, **coaches**, **team officials**, **or clubs**, helping uphold the values and spirit of the game.

# **Key Responsibilities**

- Attend tribunal hearings as required during the season typically **Thursday evenings**, either **via Microsoft Teams** or **at the WACA Ground**.
- Review evidence, consider statements, and apply MJCC by-laws, playing conditions, and relevant policies in decision-making.
- Ensure hearings are conducted fairly, respectfully, and in accordance with procedural fairness.
- Contribute to written findings and outcomes consistent with the MJCC Penalty Matrix and Tribunal Procedures.
- Uphold the principles of **child safety, inclusion, integrity and teamwork** that underpin junior community cricket.

#### **Skills and Attributes**

- High levels of integrity, impartiality, and sound judgment.
- Strong communication and active listening skills.
- The ability to remain calm, objective, and balanced in decision-making.
- Experience or interest in areas such as sport administration, education, governance, or community or club leadership (desirable but not essential).
- Commitment to upholding the values of **safe**, **inclusive**, **and respectful participation** for all young people in cricket.

#### What We Offer

- Full induction and training in MJCC Tribunal Procedures, Playing Conditions, and Codes of Behaviour.
- Mentoring and support from the MJCC Protests & Disputes
  Subcommittee.
- The opportunity to contribute to the fairness and integrity of Perth's junior cricket community.
- Recognition and engagement within a network of community sport integrity leaders.



#### Commitment

Tribunal hearings are scheduled on Thursday nights throughout the season, generally between October and March, and are conducted either via Teams or at the WACA Ground.

Tribunals are **not required every week** pending incidents that occur through the week of games, and the MJCC aims to establish a **pool of Tribunal Members**, so volunteers are only **rostered on for one or two weeks across the season**. This structure ensures a fair distribution of hearings and keeps the time commitment manageable.
